## RULES OF THE SURF SCHOOL

### **Art 1: Registration**

Any entry in the Surf School will be based on the registration form this attached form, which must be completed by the parent or legal guardian if it is a minor or by the concerned person if it is an adult.

### **Art 2 : Course Cancellation**

In case of bad weather conditions (lack of waves, too strong sea, pollution ...) the courses that can not be conducted as part of the package subscribed above will, in agreement with trainees:

- replaced by alternative activities
- deferred to a later date
- reimbursed

The courses not made by the client choice will not be reimbursed.

### **Art 3 : Structure responsibility**

Trainees will be supported by the Surf School, and therefore by the responsibility of his teachers, a quarter of an hour before the start of their surf course. They will be again under the responsibility of their parents or guardians quarter of an hour after the end of the service concerned.

The civil responsibility of the Surf School concerning its students ceases outside these hours, within the time described above.

Parents should, before letting their child to the Surf School, ensure that the course does occur.

It is highly recommended for students to leave valuables objects in the locker room (money, watch, phone...). The Surf School is not responsible for lost or stolen objects in its premises.

### **Art 4 : Insurance**

All persons enrolled in the Surf School will always get a Federal License, including warranties of Civil Liability, Personal Accident and Assistance Appeal, whose terms are described in the ALLIANZ agreement provided by the structure.

Trainees (or legal representant) can refuse warranties of Personal Accident and Assistance Appeal. However, the Surf School

The Surf School can deliver to members additional insurance coverage forms. Trainees (or their legal representatives) may refuse such insurance coverage if they feel sufficiently covered by the proposed contract.

### **Article 5 : Structure Commitment**

Under the plan selected, the Surf School is committed to respecting the Quality Charter of the "French School of Surf" Label in terms of quality care, education, supervision and safety.

The necessary equipment (wetsuit, boards...) will be provided to participants during class time.

### **Art 6: Members Commitment**

By enrolling a Surf School, minors' surfers and their parents accept the risks associated with surfing in normal practices.

### **Art 7: Trainees Transport (in case of the need to use a vehicle for the offered service)**

The Surf School is committed to provide transportation for students in compliance with the regulations:

- licensed drivers needed
- coverage vehicle insurance
- respect of the maximum number of passengers
- vehicle clean and in good condition (revisions required)

### **Art 8 : Appendix to these rules**

The Surf School reserves the right to give trainees some additional documents about its operations, specifying the types of services offered, their duration, their distribution in the week, cost...
